PRESIDENT'S MESSAGE

Let me begin this message by thanking those members who have contributed to our teacher grant fundraiser. This year we will be able to award in December grants to eight teachers in the Fallbrook Union Elementary District. We would always like to award more grants, but most assuredly your contributions and the award given will benefit the children in the Fallbrook schools.

On October 4, I attended a membership workshop held in Costa Mesa for those Divisions in Southern California. The purpose was to discuss strategies for strengthening the membership of CRTA. I came away with several suggestions but also presented several strategies our own Board members have come up with for increasing membership in Division 81. Below are five strategies we plan to implement during this next year to attract new members.

RETIRED TEACHER WEEK Nov. 2-8

Each year we are asked to remind the public that teachers and retired teachers work hard and accomplish great things, by writing letters to the editor. We can not have too many letters. Statewide, CRTA's 52,000 members volunteered 2.4 million hours this year. This is worth \$46 million that families, businesses, and the state do not have to pay. Thank you for your hard work and we know you will continue to volunteer. Also we instigated

legislation, approved by the CA Legislature, that provides a stable teacher retirement. Sacramento IS listening!

CHOLESTEROL: WHAT THE NUMBERS MEAN

The National Institutes of Health now recommends that all Americans over the age of 20 get a lipoprotein profile every five years. A lipoprotein measures total cholesterol, LDL, HDL, and triglyceride levels.

The chart below gives some guidelines for interpreting the numbers and assessing your risk of heart disease. However, it is important to remember that cholesterol levels do not paint the entire picture. Other risk factors, including cigarette smoking, high blood pressure, family history, age and diabetes contribute to heart disease.

Total Cholesterol

Desirable—less than 200 mg/dl
Borderline—200-239
High—over 240

LDL Cholesterol

Optimal—less than 100 mg/dl
Good—100-129
Borderline—130-159
High—160-189
Very high—above 190

HDL Cholesterol

Major risk for heart disease—less than 40 mg/dl
Good—above 60

Triglycerides

Increased risk for heart disease in women—more than 190 mg/dl
Increased risk for heart disease in men—more than 400 mg/dl

BEWARE OF NEW SCAMS

Jury Duty Scam

There was a recent article in the *Julian News* about a new scam which has been verified by the FBI. Most citizens take summons for jury duty seriously, but enough people skip out on their civic duty that this fraud has surfaced.

Claiming to be a jury coordinator, a caller asks why you did not report for jury service. If you protest that you never received a summons, the scammer asks for your Social Security number and date of birth so that the information can be verified and the arrest warrant cancelled. If you give this information, your identify has been stolen.

The fraud has been reported in 11 states so far. The swindle is especially insidious because they use intimidation over the phone to bully people into giving information by pretending to be with the court system.

FRAUD—SCAM ALERT

Medicare changes are being used to get into your pockets fraudulently. If anyone contacts you regarding the changes, get a phone number and name; say you “have to think about it.” Call HICAP 800-434-0222 or Social Security, 800-772-1213, and ask if the information is valid.

Don't verify any information unless you generated the call and know who you are talking to!
